# 1 Welcome

Everyone introduced themselves to the meeting. Everyone welcomed our new member, PM to the group.

## 2 Flu Vaccination Update

There is no update on a covid spring booster but we will keep members updated in due course.

SB asked for an update on shingles. ZW advised that the criteria was very confusing. The criteria is as follows:

- Anyone aged 70 80 who has not already had it
- Anyone turning 65 between September 2023 and September 2024

### 3 New Salaried GP

KR advised that Dr Islam has recently started with us a salaried GP working 4 sessions per week on a Wednesday and Thursday. Dr Islam has done some locum work for us before and did complete her GP training with us here.

### 4 Preparing for CQC Inspection – last one 2016

KR advised that we are all expecting an inspection at some point this year.

ZW & KR have been working with a lady from an outside consultancy firm to undertake a large amount of work for the GP Improvement Plan. This is a toolkit that has been developed to support practices and primary care networks to: better align capacity with demand. improve the working environment. Lots of work has taken place to look at frequent attenders but also those that have not attended for a long time. Work has been done on care navigation to get the best course of action for patients.

# 5 NHS App Drop-In Session

KR asked members for their opinion on whether they felt a drop-in session for the NHS App would be beneficial. Members of the admin team will do some extra training and then offer support to patients on how to access the app and navigate their way around it. All agreed that this would be beneficial.

## 6 APEX – Producing pact to share information with patients.
